All cards contain a magstripe for fallback processing.</p> <p>This card set is intended for customers who have purchased the B2 USA EMV Test Card Set in the past and wish to extend their existing EMV card set(s) to include Amex and Discover cards.</p>
<b>B2 USA Debit EMV™ Test Card Set</b>	<p>An introductory U.S. Debit card set that is an extension to the B2 USA EMV Test Card Set. The set includes EMV contact Visa, Mastercard and Debit Network Alliance EMV U.S. Debit cards.</p> <p>This is a limited set of U.S. Common Debit cards intended for customers who have previously purchased the B2 USA EMV Test Card Set and wish to extend their existing EMV card set(s) to include a few basic EMV U.S. Debit cards.
